

## Mevo gets ready for an impactful 2021 with vehicle supply deal and Loop acquisition

Mevo announces \$30million vehicle supply deal with Ebbett Group and the acquisition of Hamilton car share Loop

New Zealand, Monday 8 March 2021: Today Mevo, Australasia's first free-floating, climate-positive car-share, announces a \$30 million dollar vehicle supply agreement with Ebbett Group to support the continued expansion of Mevo throughout New Zealand.

As part of this deal, Mevo will take over operation of Loop car share on March 31 2021, to prepare for a transition to the Mevo app and brand later in the year. The Hamilton rollout of the technology Mevo users already know and love will ensure Hamilton-based customers continue to get an amazing car sharing experience.

**Erik Zydervelt, CEO** and founding director of Mevo, said he is excited for Mevo's biggest year to date. The vehicle supply agreement with Ebbett and the Loop acquisition will play a large part in the next phase of Mevo's explosive growth and support expansion in Wellington. This is also a key milestone ahead of Mevo's entry into Auckland & Hamilton later this year.

"The Loop team have built a great car share for Hamiltonians. As part of the deal, Loop Director, Richard van den Engel, will join the Mevo board ahead of the Auckland launch later this year.
